# Fair Food for All DC Coalition FY24 Budget Update and Call to Action – Revised and Final

The Fair Food for All DC Coalition respectfully calls for the Council's support in protecting the important investments made in the Mayor's FY24 proposed budget and harnessing the additional resources needed to address the budgets' remaining gaps that, left unmet, will leave many DC residents without the healthy, dignified food they need in the year ahead. Our coalition is comprised of respected local organizations with deep expertise in food access and food security programming, and we can speak to the urgency of addressing these remaining concerns. The below tables reflect recent and proposed funding levels for our essential programs and partnerships with DC Government. The combined efforts of these programs can be fully funded with an additional investment of **\$2,305,000**. On page two, we detail three targeted, time-sensitive investments in local legislation and system-wide initiatives totaling another \$1,042,000. These measures were previously supported by the DC Council precisely due to their power to reduce hunger and health inequities in DC, and now is the time to ensure we fulfill their promise.

<u>Updated Comment</u>: According to the Fiscal Impact Statement compiled by the Office the Chief Financial Officer, this figure represents the additional DACL staff and administrative costs associated with its responsibilities under the No Senior Hungry Legislation to convene and lead the Senior Food Security Interagency Task Force, to coordinate implementation of the Senior Nutrition Services Communications Plan, and to prepare a Senior Food Security Plan. Funding these activities is foundational to the effort to develop a comprehensive District-wide approach to combat senior food insecurity.

<u>Updated Comment</u>: Thanks to the 2018 Healthy Students Amendment Act, GFPP is already part of DC Public Schools' foodservice model – but implementation has lagged since the pandemic. If alignment with GFPP were re-prioritized by DCPS – and subsequently expanded to all District agencies – the Council could better leverage the \$80 million the District spends on food each year to create local jobs, improve our air and water, and build a more resilient and equitable food system. Given the restraints of this year's budget, we request that the Council, at minimum, prioritize funding for 1 FTE at DCPS who will oversee the program and help get GFPP back on track.

#### **Giving SNAP a Raise**

These funds will also assist with the needed transition to an electronic, simplified SNAP application process and help the District stay ahead of looming Federal changes aimed at simplifying and modifying that process nationally.
